For three previous years, Aduddell served as Executive Vice President and Chief Operating Officer of CHI St. Vincent and President of CHI St. Vincent Infirmary in Little Rock. He came to CHI St. Vincent from St. Anthony Hospital (sponsored by SSM Health Care, the first health care recipient of the Malcolm Baldridge National Quality Award) in Oklahoma City, Okla. in 2012. At St. Anthony, Aduddell served as the President of the Bone & Joint Hospital and as Chair and Administrator of the Saints Heart and Vascular Institute. He has experience in hospital

operations and physician enterprise with CHRISTUS Spohn Health System in Corpus Christi, Texas, and in physician enterprise and physician residency program management with SSM Health Care in Oklahoma City. Aduddell has a Bachelor of Science with honors from the University of Tulsa and a Master of Business Administration in Health Care Administration with highest honors from Oklahoma City University's Meinders School of Business. He has served on the Little Rock Regional Chamber of Commerce Board of Directors, Arkansas Healthcare Transparency Initiative Board, and the University of Arkansas at Little Rock College of Business Advisory Board.



Anna Strong, Executive Director at Arkansas Chapter of the American Academy of Pediatrics

As executive director of the Arkansas Chapter of the American Academy of Pediatrics (ARAAP), she leads health policy work that benefits children and pediatricians, engages members in statewide initiatives, and conducts grant-funded project work. Mellie has eighteen years of experience in community and organizational networking, grant writing, and program development and implementation. Mellie created the Arkansas Rural Health Partnership

organization in 2008 which began with five critical access hospitals and has grown to twelve member hospitals across the south Arkansas region. Mellie has obtained over \$12 million dollars in grant funds for Arkansas Rural Health Partnership to implement healthcare provide training opportunities, healthcare workforce initiatives, chronic disease programs, behavioral and mental health services, and access to care throughout the Arkansas Delta. Ms. Bridewell currently serves on the National Rural Health Association Congress and was recently chosen as one of fifteen in the country to participate in their Rural Fellows program for 2019. She also serves on the board of the National Cooperative of Health Networks Association. Ms. Bridewell has a reputation in the state of Arkansas and throughout the country as an ambassador for rural healthcare. Her ability to convene the appropriate partners and valuable stakeholders has led to state and national recognition. In 2016, Ms. Bridewell was acknowledged as a Federal Office of Rural Health's Rural Health Champion. She has led the Arkansas Rural Health Partnership for twelve years. Over that time the organization was recognized nationally as a Rural Health Community Champion for Collaborative Partnerships by the Federal Office of Rural Health and as Outstanding Network of the Year by the National Cooperative of Health Networks Association.

He led the effort to introduce capitation into the Arkansas market and worked with cross-functional teams to build the logistics to support this new type of payment model for the market. Their programs focus on the quadruple aim of improving population health, patient satisfaction, provider satisfaction, all while addressing total cost of care.
